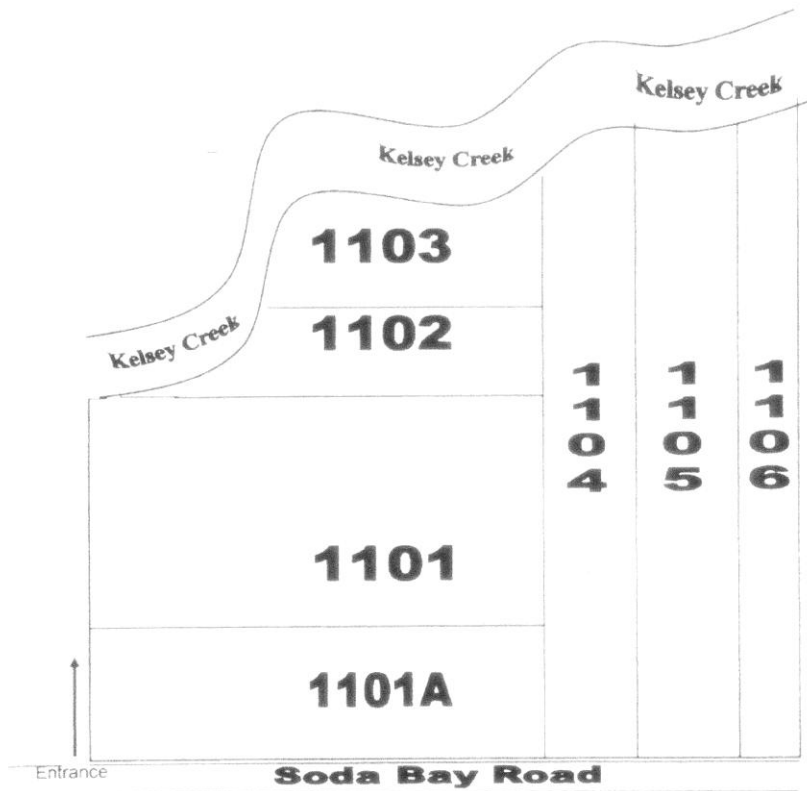

The ranch is planted to 50.73 net acres or 53.25 gross acres of vineyard.

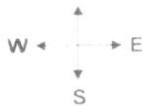
